

# PRIVACY POLICY

## A. NOTICE

- A.1. This Privacy Policy applies to [www.panda-eco.com](http://www.panda-eco.com) (hereinafter, "us", "our", "we", "Panda Eco System", or "Panda Eco System Berhad") to serve as a notice pursuant to the Malaysian Personal Data Protection Act 2010.
- A.2. We may vary or update this Privacy Policy from time to time and at Panda Eco System's sole discretion. We encourage you to check our Corporate Website regularly for any changes to our Privacy Policy. Your continued use of this site after any change in this Privacy Policy will constitute your acceptance of such change.

## B. INFORMATION COLLECTION AND USE

- B.1. We may collect and hold personal information/data ("Personal Information") about you, that is, information that can identify you, including without limitation full name, postal and email address, other contact details, identification details, bank account information and other information relevant to providing you with the services you are seeking or in relation to your present/potential employment service or communication with you, which we receive from you through our Corporate Website and other written forms. You agree that you grant us unrestricted access to the Personal Information provided herein.
- B.2. You are responsible for ensuring that the Personal Information you provide us is accurate, complete, and not misleading and that such Personal Information is kept up to date.
- B.3. We may collect Personal Information in one or more of the following circumstances or for one or more of the following purposes:
- (1) to our related companies, affiliates, advisors, contractors, vendors, or service providers for the purposes of operation and maintenance of our business, for commercial purposes, and to otherwise provide investor relation, customer support and services to you;
  - (2) to our business partners and investors;
  - (3) to other third parties with whom we have commercial relationships unless you have indicated that you do not wish for us to disclose to such third parties for business purposes; and
  - (4) as required or authorised under law or provided in co-operation with any governmental authority.
- B.4. If you fail to provide us with the Personal Information stated in paragraph B.1 above, we may not be able to perform and/or carry out any of the Purposes.

- B.5. We may use the Personal Information provided to send you information on customer survey forms, questionnaires, announcements, and corporate news unless you have indicated that you do not wish to receive such materials in written form via contact points as stated in E.1.

## **C. SECURITY OF YOUR PERSONAL INFORMATION**

- C.1. We will take reasonable steps to protect any Personal Information we receive from you from misuse and loss and from unauthorised access, modification, or disclosure except for the Purpose. We may hold your information in either electronic or hard copy form or retain third parties to hold that information on our behalf. Where required by applicable laws, Personal Information will be destroyed or de-identified when no longer needed.

## **D. ACCESS AND CORRECTION**

- D.1. You may request access to any Personal Information we hold about you or any Third Party whose Personal Information you had provided at any time by contacting us (see the CONTACTING US section below). Where we hold information that you are entitled to access, we will endeavour to provide you with suitable means of accessing it (e.g., by emailing or mailing it to you).
- D.2. If you believe that Personal Information, we hold about you is incorrect, incomplete, or inaccurate, then you may request for the amendment of it. We will consider if the information requires amendment. If we do not agree that there are grounds for amendment, then we will add a note to the Personal Information stating that you disagree with it.
- D.3. In accordance with the Malaysian Personal Data Protection Act 2010, and to the extent not limited by any other applicable law, we may refuse to comply with your request for access or correction to the Personal Information and give you a reason for our refusal.
